Dear business partner,

With this document we confirm that all materials used in our production for the making of food packaging (paper, paints, adhesives) are safe and we inform you, as a buyer of our paper products that you use for packaging foods, that our products are made of materials which can come in contact with food on the unprinted side and are suitable for packaging dry foods. In order to pack water and fat products, we recommend an additional barrier to avoid the effect of food on the physical properties of the product.

There is no harmonized European legislation for paper and cardboard packaging intended for contact with food, and for this type of materials we do not have national regulations, therefore we used German recommendations for paper and cardboard in contact with food to assess the sample (Bundesinstitut für Risikobewertung, XXXVI. Papiere, Kartons und Pappen für den Lebensmittelkontakt, XXXVI, 01.09.2017). Concentrations were lower than the lowest limit of quantification of the used analysis method and lower than the limit values in German recommendations BfR XXXVI.

On the basis of the test results and the guaranteed production processes, we give a declaration of conformity that our product COMPLIES with the provisions of Article 3 of Regulation of the European Parliament and Council (EC) No.1935/2004 of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, pursuant to the Regulation of the Commission (EC) 10/2011/EC on plastic materials and articles, intended for contact with food or Annex 10 of Ordinance of the FDHA on Materials and Articles (RS 817.023.21), 1.1.2017 and Regulation of the Commission (EC) no.2023/2006 of 20 December 2006.

The declaration of conformity is given on the basis of the documentation of the National Laboratory for Health, Environment and Food (NLHF), certificates and analyzes of our suppliers of raw materials and internal documents, which prove this and, at your request or request by the competent authorities, we pass it on or enable an insight into it.

We also have the traceability of materials in all stages of production, processing and distribution in accordance with the provisions of Regulation of the European Parliament and Council (EC) No.1935/2004.

Verification of the traceability of our products can be ensured on the basis of the submission of the following documents: delivery notes and labels on each packaging unit.

The information given in this statement is available on the basis of the actual knowledge of the product and its components, statements and analyzes of the suppliers of materials included in the product and the relevant institutions. The company [REDACTED] does not assume any liability for deviations from this information as a result of improper use of our product.

This declaration shall be valid until the date on which at least one of the materials used is replaced or the legislative references are changed in order to require a new conformity check.
