- Food stimulant: Ethanol 10% (A), Acetic acid 3% (B) and Vegetable oil (D2)
- A surface / Volume ratio of 6 (expressed in dm²/kg or dm²/L) or
- A surface / Volume ratio of 7 (expressed in dm²/kg or dm²/L)

Therefore, this film is complying with the following application:

- Any long-term storage below 30 days at room temperature
- Any long-term storage below 30 days at refrigerated and frozen condition
- Including heating up to 70°C for up to 2 hours, or heating up to 100°C for up to 15 minutes.
