All the inks and varnishes used for the printing of paper sacks are water based. Our ink supplier has stated that their products are formulated and manufactured in accordance with the "EuPIA Guideline on Printing Inks applied to the non-food contact surface of food packaging materials and article"

This declaration is valid on the date of delivery of the material or article. It is renewed whenever compliance to above is no longer ensured (change of material, change of the type of food delivered or change in regulations before delivery of the material or article).
