We further state that all our products can be in direct food contact with. Dry Food, Wet Food, alcoholic up to 20% vol, milk products up to 4,5% ph, acidic food, and fatty foods.

#### Identity of Raw Materials & Specifications on the use of the products

- Polyethylene Terephthalate (PET). Products manufactured by raw material PET Cups, Lids etc. are suitable to come into contact with Food, Hot and Cold beverages, Coffee, tea etc. from 0° up to 55°.
- Recycled PET (polyethylene Terephthalate (rPET)). Products manufactured by raw material PET Cups, Lids etc. are suitable to come into contact with Food, Hot and Cold beverages, Coffee, tea etc. from 0° up to 55°.

The produced Recyclate fulfils the **COMMISSION REGULATION (EU) 2022/1616** of 15 September 2022 on recycled plastic materials and articles intended to come into contact with foods, and repealing **Regulation (EC) No 282/2008**.

The company [REDACTED] applies a traceability system and its products have the necessary labelling for a fast recognition and traceability.

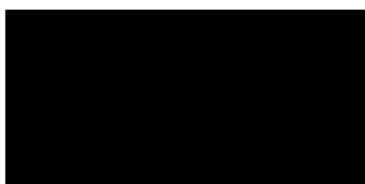
The company assures that all the necessary measures for the application of Good Manufacturing Practice according to Regulation (EC) No. 2023/2006 are used.
